

XENIA TOWNSHIP BOARD OF TRUSTEES
PUBLIC HEARING FOR JULY TAX BUDGET FOR 2019

July 5, 2018

THESE MINUTES ARE A SUMMARY OF THE EVENTS OF THE HEARING AND ARE NOT A WORD FOR WORD ACCOUNT OF THE DISCUSSIONS WHICH TOOK PLACE.

The Xenia Township Board of Trustees held a public hearing on July 5, 2018 at 5:30 p.m. at the Xenia Township Trustees Office, 8 Brush Row Road, Xenia, OH, 45385 with the following members present:

Mr. Combs called the hearing to order at 5:30 p.m.

Roll Call: Scott Miller, Trustee; Steve Combs, Trustee, Chair; Susan Spradlin, Trustee; and Sheila Seiter, Fiscal Officer; Alan Stock, Township Administrator.

Mr. Combs asked everyone to stand and participate in the Pledge of Allegiance.

Mr. Combs asked for verification of Public Notice and County Auditor Process from the Fiscal Officer. Mrs. Seiter advised that the public notice was submitted on time to the Xenia Daily Gazette for the required ten-day notice. She showed everyone a copy of the notice and the proof of publication.

Mr. Combs asked if there were any questions or need of clarification on the Tax Budget. Hearing none he asked Mr. Stock if he had anything to add.

Mr. Stock advised that he and Mrs. Seiter worked hard on the budget and that they would be coming to the Trustees soon to talk about a possible road levy. Mrs. Spradlin asked if this was a renewal. Mr. Stock advised that the current levy would not be up for renewal until 2020 and there will be a need for additional funds before that date. He stated that this was in the research phase and when there were more details he would bring those to the Trustees. He handed the Trustees an outline of the current levies for the Township. Mrs. Seiter explained the levy amounts on the Budget Schedule noting the inside (Greene County) and outside (levy mileage) for clarification. Mr. Combs asked Mrs. Spradlin if she had any comments. Mrs. Spradlin advised she did not because she had a meeting with Mrs. Seiter .

Mr. Miller moved accept the 2019 tax budget as presented by the Fiscal Officer and Administrator. Mr. Combs seconded the motion. Roll Call: Mr. Miller – aye, Mrs. Spradlin – aye, Mr. Combs – aye. Motion **PASSED** by roll call of 3-0.

Mr. Combs moved to adjourn the public hearing. Mr. Miller seconded the motion. Roll Call: Mr. Miller – aye, Mr. Combs- Aye, Mrs. Spradlin- Aye. Motion carried **PASSED** by roll call of 3-0.
