FIRE DEPARTMENT:

Chief Beegle was absent, Alan Stock presented a discussion of ordering a new medic from State Bid, form either Horton or Braun. Mr. Stock presented that the newest Medic

received Nov 2023 was ordered in Oct 2021 for \$262,686.00, Horton \$365,798.29, 36 mo. build time from time of receiving chassis, Bruan \$362,273.00, 30 mo. build time, chassis available, Graphics and [radio] approval needed when we take possession of vehicle, and the new medic would move to front line in front of 2013 Road Rescue (11 years now,14 when Medic arrives).

Mr. Miller moved to accept the quote and create a PO at the appropriate time from Penncare for a Braun Medic for \$362,273.00. Mr. Combs seconded the motion. Roll Call: Mr. Combs – aye, Mr. Miller – aye, Mr. VanDyne - Aye. Motion PASSED by roll call of 3-0.

Mr. Stock presented a discussion of getting two quotes for paint damage to M51: the medic will be taken back to Horton as well for unnoticed top paint repair from manufacturing.
