# **RECORD OF PROCEEDINGS**

The meeting was held at the Xenia Township Office, 8 Brush Row Road, Xenia, Ohio. This was a Regular Trustee Meeting advertised annually and on the Xenia Township website within 24 hours of scheduling this meeting.

Chair Steve Combs called the Regular Meeting to order at 6:00 P.M.

He stated that he would like to donate the Engine to Sinclare for training.

Mr. Combs moved to declare the 1994, 31-year-old Pierce Engine 53, obsolete with the respectful disposal of same to be determined by the Administrator and Fire Chief. Mr. VanDyne seconded the motion. Roll Call: Mr. Combs – aye, Mr. Miller – aye, Mr. VanDyne - aye. Motion PASSED by roll call of 3-0.

The Road Department world like to do chipseal, replace guardrails, striping, berming and tree trimming on the township roads. They would also like to have software update for the scanning tools, two (2) fuel storage tanks, guardrail attachment for the BobCat, a metal Mill and Lethe, and a plow truck. It ws discussed that more than one person needs to be trained on all the equipment. It was then discussed the electrical upgrade that MRL would like to do at the Road Department.

Mr. Stock presented a discussion of the raises and incentive pays from 2016 to 2024.

Mr. Stock presented a discussion on the Financial Snapshot. He stated that they are \$106,000 ahead from last year and that the interest has tripled from last year.

Mr. Stock presented a discussion on the new M55 Parcels. He stated that the parcels are not detached from Xenia Township and Xenia Township will still receive monies from property taxes and levies from these properties.

Mr. Stock presented a discussion on JEDD. He stated that JEDD has been updating their by-laws. He also stated that there is a discrepancy in JEDD payments. He stated that we should have received 67% of 2.5% of \$92,000.00

Mr. Stock presented a review of the upcoming Reorganizational Meeting to be held on December 30.
