RECORD OF PROCEEDINGS

MINUTES OF THE XENIA TOWNSHIP TRUSTEES:

SPECIAL MEETING January 13, 2025 6:00 P.M.

NOTE: These minutes are a summary of the discussion and are not a word for word account of the discussions. The proceedings were electronically recorded. The meeting was held at the Xenia Township Office, 8 Brush Row Road, Xenia, Ohio. This was a Special Trustee Meeting advertised on the Xenia Township website within 24 hours of scheduling this meeting.

Chair Steve Combs called the Regular Meeting to order at 6:00 P.M.

All participated in the Pledge of Allegiance.

ROLL CALL: Steve Combs, Trustee; Chair, Scott Miller, Trustee, Jeremy VanDyne, Trustee, Jacqueline Robinson, Fiscal Officer, Absent.

In attendance: Alan Stock; Township Administrator. Adam Bistrek, Battalion Chief, Michael Whitby, Fire Department, and Ronnie Shaw, Road Department.

TRUSTEES' BUSINESS:

Mr. Shaw presented a discussion of the issues the he has with the new Xenia Township Handbook. Mr. Shaw stated that the major issues with the handbook are not being able to get overtime if you had a holiday, vacation or sick leave during the week. He went on to say that he could agree with the sick leave, but not the holiday or vacation. The next issue was that bereavement leave is now five (5) days, but it comes out of your sick leave where before the Township would cover three (3) day. That there is no benefit for further education, the Road Department is required to have a CDL, but the Township will not cover the cost of renewal overage of a regular license. He also stated that when you are called in, there is a minimum of working two (2) hours to get paid when sometimes the job only takes 30 minutes to an hour to accomplish. Mr. Shaw went on to say that this has always been a family atmosphere and by signing the policy manual, it is signing a contract that he does not agree with.

Mr. Combs stated that signing the policy manual is an acknowledgement that you received the manual not a contract. Mr. Stock went on to say that each employee should have already signed an old policy manual when hired. He went on to say that the Township was dinged by audits because there was not an updated policy manual, so the Trustees, Lawyers and Insurance company helped to update the manual. It was again stated that signing the policy manual is an acknowledgment of receiving it, not a contract or that you agree with it.

ROAD DEPARTMENT:

Mr. Shaw was asked how much Beat Heat was left in the tanks, he stated that one tank has five (5) inches and the other has seven (7) inches.

He went on to say that the City will not renew the water contract with Central State until they have a strategy in place to maintain the water system. Mr. Urschel concluded by saying that the City will begin paving Residential streets, and that they will have a levy on the November ballot for this. He went on to say that if the levy fails, the City will place assessments per neighborhood to pay for the street paving.
